Secondary	Secondary students can also purchase an optional school jersey and bucket hat	
Other	On Sports Carnivals students are allowed to wear sun-safe clothing in the colours of their	
	sporting house (i.e. no singlet tops, short pants/skirts or open toed shoes)	
	On swimming days students must wear a rashie/ swim shirt.	
	For representative sports the school will loan a Quinalow District Sports Association shirt	
	to students.	
	Free dress days are usually organised once a term and for some special events. These	
	will be announced in the school newsletter. Sun-safe clothing must be worn (as outlined	
	above). Inappropriate logos or pictures on free dress clothes are not acceptable.

Responsibilities:

Principal:

- Communicate dress code requirements to the community and students
- Include the dress code in documentation upon enrolment
- Enforce the dress code fairly and equitably
- Determine dress code exemptions
- Monitor issues
- Review the dress code

P&C:

- Support and engage in consultation led by the principal
- Direct parents to the principal to discuss any individual issues regarding the dress code
- Support the school in resolving issues regarding the school's dress code

Parents:

- Commit to supporting the dress code as part of the enrolment agreement
- Support students to adhere to the dress code
- Request dress code modifications or exemptions in writing, providing reasons
- Work with the school to resolve issues regarding non-compliance to the dress code
- Engage in consultation processes about the dress code

Our policies:

Non-compliance	Non-compliance is defined as:	
	- student not wearing the correct uniform as stated above,	
	- student wearing clothes that are inappropriate for school e.g. too short or small	
	Students who do not comply with our school dress code will be managed in	
	alignment with our Responsible Behaviour Plan for Students: "Always Respectful – I wear my uniform with pride"	
	Non-compliance is considered a 'minor behaviour' until a warning is given – non-	
	compliance is then considered a 'major behaviour'	
	Excess coloured make up and fake nails are also inappropriate for school	
Financial hardship	For families experiencing financial stress we have second hand uniforms available	
	for a lesser cost	
Gender Neutral	Our uniform shop will supply clothing to parents as requested – we have a gender neutral policy.	
Ordering	Office staff will supply parents with an order form, which can be filled out	
_	(including contact details) and handed back in to the office. Our uniform shop	
	volunteer will contact parents at the earliest convenient and appropriate time to	
	organise the purchase.
